The mission of the CMSA Foundation is to **positively** impact the practice of case management by funding and publishing research and process improvement **practices** to increase awareness of case management contributions to the healthcare industry. In 2023, Kaiser Permanente of Washington received the CMSA Foundation Practice Improvement Award for their Virtual Inpatient Case Management Program. The program focused on individuals hospitalized for acute respiratory conditions during the COVID pandemic. Case Managers reduced rehospitalizations through critical time interventions that also increased patient satisfaction. Kaiser’s model also helped retain staff at a crucial time. The CMSA Foundation chose to recognize the Kaiser Permanente program with a Practice Improvement Award because this evidenced-based practice is translatable and can be adapted to multiple practice settings.

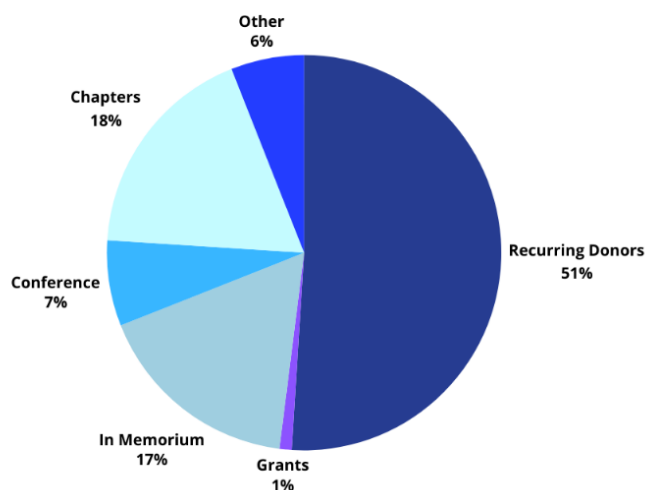
Financial Overview

Total donations in 2023 covered only 77% of the Foundation’s administrative expenses. The Foundation Board is made up of volunteers who receive no compensation for their service. The Foundation receives no financial support from CMSA.

Operational costs include monthly management fees for PMG staff time, insurance, database and website fees, legal retainer, and business registration fees.
